The Governing Body ratified and confirmed the approval of the Chairperson, Governing Body dated 08-02-2024 approving the aforesaid panel of names of Auditors to audit the accounts of the College for the Financial Year 2023-24.

The Governing Body ratified and confirmed the approval of the Chairperson, Governing Body dated 05-02-2024 approving to write off the amount of Rs.51,980/- to be recoverable from M/s. Kumar Caterers in 2005-06 against the electricity charges and rent (Rs.41,980/- for electricity and Rs.10,000/- for rent) as the award of contract to run the canteen in the College was awarded to him on 01-12-2004.





Note: The canteen contract was awarded to M/s. S.Kumar Caterers on 01-12-2004 and he was supposed to deposit Rs.10,000/- as rent annually to the College as per agreement dated 22-12-2004. As per Clause No.-09 of the agreement between the College and Canteen Contractor, the Contractor was supposed to pay the electricity dues. There is balance amount of Rs.41,980/- which was supposed to be recovered from canteen contractor against the electricity charges. There is also a balance payment of annual rent amounting to Rs.10,000/-. The total amount of recovery comes out to Rs.51,980/-. The Office of Directorate of Audit, Govt. of N.C.T. of Delhi conducted the Audit for the period from 2016-2017 to 2018-2019 in November-December, 2020 in the College and recommended as per Audit Memo No.-08 (Para pertaining to Old Audit Report 2004-16) that since there is no possibility to recover the amount of Rs.51,980/- from the said contractor, it is suggested to write off the amount and intimate the same to the Directorate of Audit.

 - iv. Keep the official work pending and writing unnecessary emails and letters.
 - v. Other misconducts.

The Governing Body members noted that the Competent Authority of the College vide Notice No.SBSC/457 dated 23-06-2023 constituted a Five-Members Inquiry Committee comprising of Dr. Jai Ram Meena, Associate Professor of Economics (Anti-Discrimination Officer of the College) as its Convener; Prof. Anu Mehra, Faculty of Law, University of Delhi, Prof. D. R. Saklani, Bursar/Senior Faculty, Dr. Suraj Mal, Associate Professor, Department of Geography, Mr. Ranu Kumar, Administrative Officer, Maitreyi College, University of Delhi as its members.

The said Committee was given the mandate to conduct a <u>detailed inquiry</u> about the following insubordination and misconducts by Mr. Jitender, Senior Technical Assistant (STA) in fair and transparent manner and submits its report to the Competent Authority at the earliest:

- i. Refusal to do official work.
- ii. Using dilatory tactics causing delay in disposal of work assigned to him.
- iii. Not obeying the lawful directions of the Senior Officers/insubordination.
- iv. Keep the official work pending and writing unnecessary emails and letters.
- v. Other misconducts.

The Governing Body members also noted that the College has received the Inquiry Report dated 20.03.2024 from the Five-Members Inquiry Committee constituted for the aforesaid matter.

The Findings of the Inquiry Report were discussed in the meeting. The Governing Body noted that based on the detailed examination of charges, defence statement of Mr. Jitender, statement of witnesses, cross examination of witnesses, documents produced before the Inquiry Committee, the Inquiry Committee prepared and submitted its report. The Governing Body noted that total numbers of 20 charges out of 22 in total charges imputed against Mr. Jitender have been proved.

After the detailed discussion, the Governing Body took serious note of the fact that apart from insubordination and other misconducts including putting false caste allegations against the former Principal and senior officers of the College, Mr. Jitender did not stop his misconduct even after suspension as he deliberately did not give the passwords of the official master login of email portal of the College in order to harass the College authorities on the pretext that he has forgotten the passwords. Further, even during inquiry proceedings, he continued with his misbehaviour with the Inquiry Committee members and tried to delay and derail the inquiry proceedings. Lastly, he started avoiding cross examination of the remaining witnesses and did not attend the hearing on false medical grounds by malingering to be ill which was substantiated by the same doctor Dr. Parmod Gupta, Mata Roop Rani Maggo Hospital from whom he forcefully procured 05 days bed rest.

The Governing Body after going through the detailed examination and findings of the inquiry report found that Mr. Jitender is an exceptional case of habitual insubordinations and other grave misconducts that seems to be a fit case for imposition of major penalty on Mr. Jitender as per Rule 63(x) of University Non-Teaching Employees (Terms and Conditions of Service) Rules-2013 (Under Ordinance XXII-D), i.e., dismissal from service.

However, before proceeding further, the Governing Body decided that, notwithstanding anything above, Inquiry committee may give Mr. Jitender a last and final chance to appear before the Inquiry committee for cross examination of the remaining witnesses, and submit the final report after incorporating changes in the finding of the report, if any due to proving or disproving of the charges on the basis of the cross examination of the remaining witnesses. The copy of this final report shall be provided to Mr. Jitender and if he so desires, he may submit a written representation to the Disciplinary Authority within fifteen days from the receipt of the findings of the report. If Mr. Jitender fails to appear before the Inquiry committee in this last chance for cross examination of remaining witnesses for whatsoever reason, no more chance be given to him and the already submitted report shall be forwarded to Mr. Jitender and for which he may submit a written representation to the Disciplinary Authority within fifteen days from the receipt of the findings of the already submitted report.

There being no other item, agenda of the Evening College was taken up.
