This is with reference to Tender ID No. 2023\_DU\_754185\_1 opened on 21.06.2023 on CPP Portal regarding procurement of **Construction of New Rooms (Three story and Renovation Work of Staff Room (Room No.-B-6) and Toilets) at Shaheed Bhagat Singh College, Sheikh Sarai, New Delhi- 110017.**

The Technical Bid Evaluation Committee opened the Technical Bids of the said tender on 21.06.2023 of the following firms:

2. M/s NCI Global Infratech

The committee noted that aforesaid Bids have required certain technical criteria and specific & additional terms & conditions to be fulfilled to become eligible for participation in Financial Bid. However, it has been observed that certain criteria is being claimed to be fulfilled by the tenderer but the relevant documents / information in supporting of that claim has been found missing (refer summary sheet attached with comments **Submitted or Not Submitted** in the relevant column of technical criteria). **Therefore, the tenderers are given an opportunity to submit the relevant documents / clarification to substantiate their claim upto 06<sup>th</sup> July, 2023 on CPP Portal, failing which it would be presumed that the tenderer has nothing to submit in support of their claim, and the committee would proceed with the decision regarding the tender meeting the technical criteria and specific and additional terms & conditions.**
